In order to resolve discrepancies between the Career College Association Political Action Committee (CCAPAC) financial statements and Federal Election Commission (FEC) report balances, a thorough audit was conducted. In light of this review, the following findings were discovered.

1. Seven (7) check disbursements totaling \$3,675.00 were listed as expenditures on the 6/30/85 FEC report, but the checks never cleared and the report has not been adjusted. These checks (#886, 871, 881, 883, 885, 887, 891) were written between 2/95 - 7/95. Unsuccessful attempts were made to locate the 1995 check account ledger to determine the recipients of the checks. Each of the Congressional committees that the CCAPAC reported contributions to during this period was viewed on the FEC web site to determine which committees did not report contributions from the CCAPAC. This effort was unsuccessful.
2. On the 9/30/86 report, \$500.00 of itemized receipts was under reported on the summary page due to an adding error. Additionally, credit card contribution service fees totaling \$401.68 were not reported as expenses.
3. On the 6/30/97 report, \$17.00 was over reported as expenses due to arithmetic error.
4. On the 12/31/97 report, \$0.40 was under reported in receipts and \$4.32 was over reported in expenses due to arithmetic error.

The CCAPAC is beginning to automate its checking account procedures and use the FEC electronic filing software to assist in simplifying the process and reducing errors.
