The National Football League ('NFL') provided 12.75 hours of professional staff time (valued at approximately \$2600.86) and 9.25 hours of administrative staff time (valued at approximately \$203.50) with respect to PAC activities such as fundraising and decision making about contributions. All of the services, with respect to PAC activities such as fundraising and decision making about contributions, that the NFL donated to the PAC for the period of November 27, 2018 through December 31, 2018 took place on November 28, 2018 through December 20, 2018. On July 31, 2018 and December 4, 2018, Gridiron-PAC made a \$3,500 and \$10,000 in-kind services prepayment to the NFL for non-administrative services. The total funds retained by the NFL on prior prepayments, as disclosed on the 2018 Post-General Report, was \$6657.72. In this reporting period, the prepayments are used to offset \$2804.36. The total funds retained by NFL as of December 31, 2018 is \$3853.36
