Dear Mr. Wiquist:

This letter is in response to your inquiry dated April 6, 2005.

The first matter you address is the receipt from our affiliated local union, IFPTE Local 195. Local 195 was acting as a collecting agent for purposes of transmitting contributions to this Committee. The contributions were collected from the organization's members and their families. No one contribution was over \$200.00 individually or in the aggregate for the year, and thus no itemization is necessary. We have filed an amended report (copy attached) for the period and removed the entry as an itemized receipt. It is now included with the other unitemized receipts on the summary page.

The second item in your letter requests further clarification about a payment of \$47,086.50 listed on Schedule B as "transfer to non-federal account". You advise those committees that have established separate federal and non-federal accounts and make disbursements in connection with federal and non-federal elections must allocate their expenses pursuant to 11 CFR §§106.6 and 106.7. Please be advised that this payment was made to an account established by the committee's connected organization, the International Federation of Professional and Technical Engineers, AFL-CIO (IFPTE)-a labor organization-that will be used solely with respect to internal IFPTE membership communications, education and other activities with respect to the IFPTE's political and legislative program. This is not a non-federal account of the committee, and it will engage in no activity that would require it to register with the Internal Revenue Service under 26 U.S.C. §527. Neither the committee nor IFPTE itself sponsors a non-federal account whose activities might be allocable with the committee. Therefore, allocation is not required with respect to the payment issue. Upon further review in preparing

this response, we acknowledge that this payment was incorrectly described, and it would be more accurate to describe the purpose of this payment as "internal membership political communications". Also, in connection with both this inquiry and your inquiry concerning Schedule H4, (the fourth item referred to in your letter) we have determined that it was incorrect to include Schedule H4, as the committee had no shared federal / non-federal activity during the reporting period. Accordingly, although we do not believe any corrective action is necessary with respect to allocation of expenses, we have prepared and filed an amended report to reflect a more accurate description of the purpose of the payments at issue, to delete Schedule H4 and to omit entries on it from Line 21(a), and to reflect the payments now on that schedule to instead in Schedule B on Line 21(b).

Lastly, the third item of your letter regards the use of the official name of the connected organization. This has been an ongoing issue with the FEC since we began filing reports electronically. We use the FEC software to prepare and file our reports. The committee name that is imported into the report was copied from the FEC's database Look-Up feature. When "copied" into the report, it comes in as shown on the report "International Federation/Professional". We have tried to use the full name of connected organization along with the committee name, International Federation of Professional and Technical Engineers Legislative Education Action Program-Political Action Committee", but as you can see from our efforts in the Amended filing the FEC software allows only enough characters in the Name of Committee field to allow "International Federation of Professional and Technical Engineers Legislative Education A". We would appreciate any suggestions you have to correct this problem. We have done all we possibly can to meet this requirement.
