The Commission's preliminary review of the report referenced above raised questions concerning certain information contained in the report. We have addressed the questions below:

1. The totals listed on Line(s) 11(a)(i), 11(a)(iii), and 11(b), Column B of the Detailed Summary Page(s) are correct and reflect amendments filed for previous reports.
2. The contribution received from "DRIVE Committee" was inadvertently deposited into our federal account. We have amended the report referenced above to disclose in the description "refund of contribution made 12/31/13." A photocopy of the refund check has been mailed to the Federal Election Commission.
3. The debt disclosed to "Firefighters Print & Design" was entered as \$37,528.00 in error on the October Monthly Report. The correct amount is \$375.28 and is disclosed on the amended October Monthly Report filed January 21, 2014.
4. The debt payment of \$319.43 to "Firefighters Print & Design" was inadvertently entered on Schedule H4. We have amended the report to correctly disclose payment of \$319.43 on Schedule B, Line 21(b).

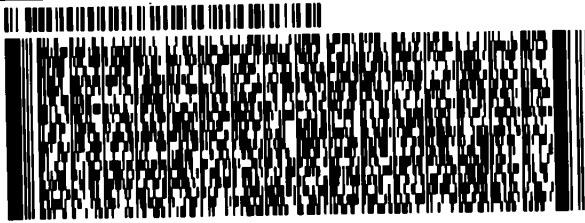

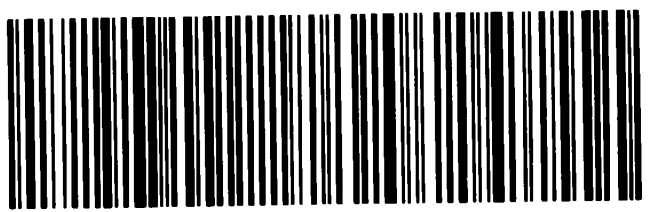
