This letter is prompted by your letter of December the 21st, 2007.

I have enclosed an up-dated FEC Form 1. I hope I was supposed to do this. I hope that this answers the first question in your letter.

With respect to the second question, the Consumer Fireworks Safety Association (CFSA) is the trade association established to promote the safe and responsible use of consumer fireworks. It is funded by a consumer fireworks import, wholesale and retail company.

With respect to the third question, the Consumer Fireworks Safety Association Political Action Committee (CFSAPAC) is funded by the same company in compliance with state laws of the State of Washington. All contributions to state and local candidates are reported as required.

Finally, the Consumer Fireworks Safety Association Political Action Committee—Federal Account (CFSAPACFA) accepts contributions only from individuals as required by federal law and supports only federal candidates.

I hope that this letter and the amended FEC Form 1 answer all questions and comply fully with all federal campaign laws.

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
