This correspondence is in response to your letter to Robert E. Synowicki, Treasurer, Werner Enterprises Inc. Political Action Committee, received in our office on August 29, 2001. We are enclosing herewith three Amended Reports. The first Amended Report corrects the contribution of \$3,000 made to Lee Terry for Congress in June of 1999 to reflect that it was in fact a contribution to his primary election campaign. The second Amended Report corrects the contribution to Ben Nelson for U.S. Senate dated May 9, 2000, to reflect that the contribution was also for the primary rather than the general election.
