RESOLUTION

WHEREAS, on August 1, 1984 the affiliation of the former Federation of Telephone Workers of Pennsylvania with Communications Workers of America became effective, and,

WHEREAS, the former Federation of Telephone Workers of Pennsylvania became an affiliated Local Union of Communications Workers of America, AFL-CIO, known as Local 13000, and

WHEREAS, Federation of Telephone Workers of Pennsylvania ceased to exist as of August 1, 1984, and all of its assets, securities, stocks, bonds, bank accounts, real estate, collective bargaining agreements and all other assets became the property of Communications Workers of America Local 13000,

NOW THEREFORE, the Executive Board of Communications Workers of America Local 13000 adopts this Resolution to avoid any further problem or difficulty with securities or other assets held in the name of Federation of Telephone Workers of Pennsylvania, as follows:

1. All securities, whether equities, fixed income securities, government issues, etc. owned by Federation of Telephone Workers of Pennsylvania shall be considered to be the property of its successor, Communications Workers of America Local 13000.
2. All officers of Communications Workers of America Local 13000 who were authorized to sign checks on the accounts of Communications Workers of America Local 13000 shall be authorized to cash in, execute the necessary papers and receive the assets of all securities formerly held by Federation of Telephone Workers of Pennsylvania and such securities are, in fact, the property of Communications Workers of America Local 13000.
