Addendum Line 15

Line 15 is an adjusting entry based on suggestions from a November 29, 2010 telephone conversation with ALLEN NORFLEET, FEC Analyst, ext. 1159. The \$1,859 represents APFA payroll deductions for the APFA PAC from calendar years 2006, 2007, 2008, 2009 and 2010 that were inadvertently retained in the APFA general treasury and not deposited into the APFA PAC until November of this year, as soon as the mistake was discovered. The only person to reach or exceed \$200 in payroll deductions in a calendar year during those years was Tommie Hutto-Blake in 2007. The total amount collected from Ms. Hutto-Blake in 2007 was \$360.00; her address at the time was 33 Christopher Place, Ridgewood, NJ, 07450; in 2007, Ms. Hutto-Blake was employed by the APFA as its President.
