This letter is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 1 item(s):

- Your committee filed 24 hour reports informing the Commission of independent expenditures made in support or opposition of federal candidates with "Wisconsin Right to Life Victory Fund" and "Wisconsin Right to Life" as the payees. However, the names of the vendor disclosed on these reports do not appear to correlate with the entries on Schedule E, supporting Line 24 for the reporting period. Additionally, the date of dissemination disclosed on these report(s) do not appear to correlate with the entry on Schedule E, supporting Line 24 for the reporting period. If your committee has filed a 24 hour report supporting independent expenditures not reflected on your reports, you must file Schedule E during the appropriate reporting period to disclose these payments. Please amend your report to clarify this discrepancy and provide further information concerning these reports. (11 CFR §104.4)

**Please note, you will not receive an additional notice from the Commission on this matter.** Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**
