Dear Mr. Norfleet:

The Year-End report filed on Jan. 31, 2012 for Sandler, Travis and Rosenberg P.A. Political Action Committee ("STARPAC") disclosed a \$1,000 refund from Bill Nelson for U.S. Senate (Transaction ID SA16.4727). The letter is provided to explain the circumstances of the refund.

On February 23, 2011 STARPAC contributed \$1,000 to the primary 2012 election of Bill Nelson for U.S. Senate. On September 30, 2011, STARPAC inadvertently contributed an additional \$5,000 to the primary 2012 election of Bill Nelson for U.S. Senate. As a non-multicandidate political committee, STARPAC may contribute \$2,500 per election.

STARPAC, immediately after delivering the \$5,000 check, realized the error and requested a redesignation of \$2,500 of the contribution to the General 2012 election and a refund of the excessive \$1,000 in accordance with 11 C.F.R. §110.1(b).^{*} On Nov. 11, 2011, STARPAC received the refund check from Bill Nelson for U.S. Senate and a letter outlining the redesignation of STARPAC's

^{*} If any contribution exceeds the limits, a PAC must request a refund of the excessive amount or provide a written authorization for a redesignation of the contribution pursuant to 11 C.F.R. §110.1(b) within 60 days of the treasurer's receipt.
