The expenditure disclosed on Form 24 on November 6 was for a communication that was disseminated on November 4 that was not authorized by the committee. Several advertisements were considered for that date. This ad was among those was not approved and the newspaper was not authorized to run the ad. The committee was unaware of the newspaper's error of placing the ad until receipt of an invoice on November 6. While not approved and authorized, the ad had been printed so the committee elected to pay the invoice. To best serve public disclosure needs, the committee immediately filed a 24-notice for the unauthorized ad anyway.
