The original November 20th filing reported \$8194.00 in independent expenditures. This money represented the cost of email communications using express advocacy. Upon further review, it was determined that these email communications were not independent expenditures since the recipients were the League of Conservation Voters restricted class, not the general public. Thus, the cost of these communications are being reported as an operating expense on line 21. There are also two itemized contributors on the November 20th report that are missing employer and occupations: Joseph K. Davidson and E. H. Kloman. The LCV PAC has been in the process of complying with the FECs best efforts procedures: both donors received an original solicitation that had a clear and conspicuous request for their contributor information, noting the federal legal requirements for the reporting of such information; within 30 days of receiving their contributions, both donors were mailed a formal stand-alone request without a solicitation requesting the missing information, also stating the federal legal requirements for reporting such information. Also included was a self-addressed stamped envelope and contact information in the event the donor needed additional information.
