
An amendment to the above-referenced is being filed with the Commission to correct an error that recently came to our attention.

In accordance with FEC regulations, ARAPAC solicits its members for both contributions to the ARAPAC and for the ARA general treasury fund to support the administrative and overhead expenses incurred for the daily operation of ARAPAC. At the time the April 2003 Quarterly Report was being prepared, ARA hired a new Director of Finance. That new Director of Finance, who was in charge of preparing and filing the FEC Report, mistakenly included the names of four individuals on the FEC Report as having contributed to the ARAPAC. However, the funds in question were not deposited into the ARAPAC, but were directly deposited into the ARA general treasury fund to support the before mentioned administrative efforts. Those itemized transactions will be deleted from the April 2003 Quarterly Report and the attributed contributions deleted from the summary and detailed summary page receipts.

The amended report also reflects the transfer out of contributions that were questionable as to whether they were contributed from corporate sources. These transfers occurred within the thirty (30) day period of time from receipt as required by the FEC regulations.
