Dear Mr. Smith:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Line 6(a) of the Summary Page represents the total cash-on-hand as of January 1, 1996. The figure disclosed on this report differs from the January 1, 1996 totals disclosed on all other reports filed during the calendar year. In contrast, the figure disclosed on Line 6(a) of this report corresponds with the ending balance disclosed on your committee's Amended 1995 Year End Report (dated April 22, 1999). In addition, there is a discrepancy between the beginning cash of the Amended 1996 Year End Report and the ending cash balance of your Amended 1996 30 Day Post General Report. It appears that your committee has filed an amended Year End Report which discloses previously undisclosed financial activity, however no amendment has been made to the cash-on hand figures of subsequent reports. The Commission recommends that you correct the apparent discrepancies between your cash-on-hand figures by submitting a comprehensive amendment covering the period January 1, 1996 through December 31, 1996. The comprehensive amendment should include the Summary and Detailed Summary Pages. Please provide an amendment(s) to correct these apparent discrepancies.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter. If you need assistance, please feel free to contact me on our
