

The services were provided on various dates by Katie Phillips (\$119.58) and Jeffrey Campbell (\$51.66).

This memo text refers to the in-kind contribution of \$85.41 from Dickstein Shapiro LLP for administrative costs, which is reflected on line 11a and 21b. These in-kind services provided by the firm represent very limited staff time, overhead, supplies, and postage associated with functions, such as raising funds for the PAC. No separate staff or office space is available for PAC administrative functions and almost all communication is via the Internet. Thus, resulting administrative costs are minimal.
