Re: Amended FEC Report

On February 8, 2005 Tiahrt for Congress filed an amended April 2002 Quarterly FEC Report and for the first time reported an in-kind contribution in the amount of \$1,500 from the Greenberg Traurig Political Action Committee ("GT PAC"), described as "in-kind use of boxes."

We represent GT PAC, and write to inform you that GT PAC made no such in-kind contribution to Tiahrt for Congress. We believe any contribution you received in the form of the use of boxes at sporting and entertainment venues was a contribution either from former GT employee, Jack Abrahoff, or from an entity he controlled. After reviewing the relevant records, however, we can confirm that it was not a contribution from GT PAC or from the firm, as they did not maintain or control any such boxes. Please amend your FEC reports to reflect the absence of an in-kind contribution from GT PAC.
