If the latter is the case, please do not include the candidate's name on your report. Please amend your report to clarify the ultimate recipient of this contribution.
2. Schedule B supporting Line 23 of your report discloses a contribution to "Democratic Congressional Campaign Committee"; however, you have also disclosed "Michael E. McMahon" for this transaction. Please clarify whether this was an earmarked contribution made by your committee through "Democratic Congressional Campaign Committee" to this candidate, or if you made the contribution to the political committee exercising no direction or control over how the funds were to be used. If the latter is the case, please do not include the candidate's name on your report. Please amend your report to clarify the ultimate recipient of this contribution.

**Please note, you will not receive an additional notice from the Commission on this matter.** Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action

will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
