## RE: RFAI Regarding 2011 Year-End Report of Skadden <br> Arps PAC (Identification No. C00232629)

Dear Ms. Benitz:
This letter responds to your letter dated March 22, 2012, inquiring about Skadden Arps Political Action Committee's ("Skadden PAC's") Amended Year-End Repart (07/01/2011-12/31/2011).

You asked about a negative entry on Line 29 of Schedule B of the report. Your letter notes that if the figure represents a vendor writing a refund/rebate check on its account, then it should be disclosed on Line 15 of Schedule A as a receipt of offsets to operating expenditures, and you asked that we amend the report either to move the entry accordingly or to provide clarifying information.

In fact, the entry in question reflects the voiding of an uncashed check for administrative expenses originally issued in August 2010. Based on the instructions for Form 3X, we believe that the voided check is properly reported on Line 29 of Schedale B. In order to clarify the nature of the entry, as you requested, we have electronically amended the report to include a note stating that the entry is to void an uncashed check from 2010. Earlier today, we attempted to call you to confirm that this amendment would address your concerns. As you are crrrently out of the office for field work, we were directed to your colleague, Christopher Morse. Mr. Morse confirmed that the entry should remain on Line 29 of Schedule B, and stated that amending the report to provide clarifying information that the entry is for a voided, uncashed check, along with the original date of the check for cross-reference, would satisfy the reporting and public disclosure requirements.
