Dear Mr. Huckaby:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Schedule H2 of your report indicates that your committee participated in L5BE, L5CF, L5IC, L5LD, L5PC, L5RT, L5SP, L5TM and L5TR fundraising activities or events during the reporting period. However, there are no corresponding disbursements reflected on your Schedule H4. If any disbursements were incorrectly reported, you should file an amended Schedule H4 with the correct unique identifying code or title.

Note that you need not include activities on Schedule H2 if there are no corresponding payments made for the activity during the reporting period.

-Your EVENT YEAR-TO-DATE calculations for the fundraising events A6BE, A6IC, A6LD, A6PC, A6RT, A6SP, A6TM and A6TR are incorrect. EVENT YEAR-TO-DATE totals for administrative and voter drive costs are derived by aggregating all disbursements during the calendar year for the whole Administrative/Voter Drive category. EVENT YEAR-TO-DATE totals for fundraising, direct candidate support, and exempt activities are derived by aggregating all disbursements during the calendar year within a specific event. These should be calculated by adding the latest disbursement for a category or event to the previous EVENT YEAR-TO-DATE total for that category or event. This running EVENT YEAR-TO-DATE total should be disclosed after each disbursement is listed. Please amend your report by providing the correct A6BE, A6IC, A6LD, A6PC, A6RT, A6SP, A6TM and A6TR EVENT YEAR-TO-DATE totals.

-Your Schedule I for the NON-FEDERAL account discloses \$29,060 in transfers from the National Republican Senatorial Committee (enclosed) which are not disclosed on the FORM 3X for the National Republican Senatorial Committee. Please amend your reports to clarify this apparent discrepancy.

-Your report includes computer produced formats of Schedule A. Computer produced formats may only be used upon prior approval of the Commission. You should submit a separate sample format with a cover letter requesting approval. Until your format has been approved, FEC forms must be used. 11 CFR §104.2(d)

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
