

Unfortunately, QC was recently notified by the Federal Election Commission that we had exceeded contribution limits. In 2006, according to U.S.C. §441a(a) contributions by a non-multicandidate political committee or its affiliates in excess of \$2,100 per election to candidates seeking federal office were prohibited. QC only recently met the criteria and filed for multi-candidate status. Therefore, we must regretfully request a refund of \$2900. We will be disclosing the request for refund on our upcoming FEC report to reflect such. Thank you.

QC only recently met the criteria and filed for multi-candidate status. Therefore, we must regretfully request a refund of \$700. We will be disclosing the request for refund on 3rd Qtr.
