This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Please provide the totals for Lines 11(a)(iii) 11 (d), 19, 20, 30, and 31, Columns A and B, of the Detailed Summary Page.

-The Summary Page discloses \$871.86 on Line 6(c), but the Detailed Summary Page shows the Line 19 total to be \$0.00. These figures should be the same. Please amend your report accordingly.

-The Summary Page discloses \$606.00 on Line 7, but the Detailed Summary Page shows the Line 30 total to be \$0.00. These figures should be the same. Please amend your report accordingly.

-For your information, all contributions received that aggregate \$200 or less per individual for the calendar year should be reported on Line 11(a)(ii). Contributions received aggregating over \$200 per individual for the calendar year should be reported on Line 11(a)(i) and itemized on Schedule A.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this
