
Dear Mr. Smyth:

Any activity occurring outside this reporting period should be included in the appropriate report(s). 2 U.S.C. §434(b)

-The Summary Page discloses \$29,811.39 and \$2,985,523.98 on Line 7, but the Detailed Summary Page shows the Line 30 totals to be \$33,447.28 and \$2,989,159.87. These figures should be the same. Please amend your report accordingly.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
