We are in receipt of the letter from the Commission regarding the above referenced report. Please see below for our complete response.

1. The excessive contribution in question was part of an import of direct mail donors into our contribution database. Since our direct mail vendor had already deposited the contribution, we reported the full amount accurately as it was made. We have issued a refund to the donor for the excessive portion of the contribution and it will be reflected on our upcoming October Quarterly Report.
2. We are aware of the parameters set forth by the Commission in regard to calculating net debts for the campaign. When the contributions designated to General 2010 on the July Quarterly Report were received we had not yet met our limit for allowable funds raised towards the general. We are actively tracking contributions for this election period and once we reach our net debt limit we will cease accepting contributions for the 2010 general election.





