
As directed in your August 29, 2001 letter, enclosed please find amended filings covering the 2000 12-Day Pre-Election Report and the 30-Day Post Election Report for the Precision Machined Products Association Political Action Committee (FEC Identification Number C00110858).

The 12-Day Pre-Election Report has been amended to reinstate the \$1,000 contribution to the Dickey for Congress Committee (sent to the Dickey campaign but returned since they did not accept PAC contributions).
