
First of all, let me apologize for the fact that you did not receive a reply to your March 3, 1999, letter. As I explained to Ms. Wilkens, I have just returned from maternity leave and the letter dated 3/3/99 was not received by the co-worker who was filling in for me.

In reviewing the information you sent regarding the possibility of exceeding the contribution limits set forth in the Act. 2 U.S.C., I noted that a clerical error was made in the 1997 year-end report. This report indicated that the FTNC Federal PAC made a contribution on 8/22/97 to Frist 2000 in the amount of \$2,000 to the general election. This contribution was actually made to the primary. I have double-checked this with the Frist 2000 office, and their records also indicate that the \$2,000 was for the primary.

I have researched all contributions made to Frist 2000, and once this clerical error is corrected we should be in compliance. Attached is the amended 1997 year-end report for your records.
