Since 2011, Covington \& Burling LLP PAC has made multiple prepayments to Covington \& Burling LLP to off-set potential staff time in excess of $\$ 5,000$. As of January 1, 2022, the pre-payment balance was $\$ 776.30$. Covington \& Burling LLP PAC paid Covington \& Burling LLP an additional \$5,000 on 9/29/2022 (SB21B.20299). In this reporting period, the remaining prepayment balance is used to offset $\$ 247.50$ in additional federal operating expenditures.
