Dear Mr. Rivera:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Line 5 of the Summary Page of your report discloses incorrect coverage dates for the 30 Day Post-General reporting period. In addition, your report discloses activity that falls outside of the proper coverage period. Be advised that the 30 Day Post-General reporting period should include only the financial transactions that occurred between 10/17/96 through 11/25/96. Please amend your report to clarify this discrepancy.

-Please provide the totals for Lines 11(d) and 15, Column B of the Detailed Summary Page. Note that changes in your figures may affect your Column B totals on this report and/or on subsequent reports.


-The outstanding balance of a debt owed to a creditor at the close of one report should be exactly the same as the beginning outstanding balance of the next report. The 12 Day Pre-General Report shows an ending balance to Andy Reynolds & Co. of \$0, while this report shows a beginning balance of \$1,052. Please amend your report to clarify this discrepancy.

-The Commission notes your letter regarding the reimbursement to the non-federal account for the "inadvertent payment of administrative expenses." Although the Commission may take further legal action concerning the

activities conducted by your non-federal account, your prompt corrective action will be taken into consideration.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
