Dear Treasurer:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 2 items:

1. Commission records indicate that your connected organization is "United Brotherhood of Carpenters and Joiners of America Local Union 1024." However, your Statement of Organization does not disclose the name and relationship with this entity on Line 6. Please amend your Statement of Organization to clarify this discrepancy.

2. Please clarify your relationship, if any, with "Carpenters Federal PAC of Philadelphia Metropolitan Regional Council of Carpenters," "Empire State Regional Council of Carpenters Political Action Fund - Federal," "Southwest Regional Council of Carpenters Carpenters Legislative Improvement Cmte," and "United Brotherhood of Carpenters/Joiners of Amer New England Reg Carpenters Legis Emp Cmte," which appear to be affiliated committees. For further guidance on the question of affiliation, please refer to 11 CFR §100.5(g) and §110.3. If your committee is affiliated with "Carpenters Federal PAC of Philadelphia Metropolitan Regional Council of Carpenters," "Empire State Regional Council of Carpenters Political Action Fund - Federal," "Southwest Regional Council of Carpenters Carpenters Legislative Improvement Cmte," and "United Brotherhood of Carpenters/Joiners of Amer New England Reg Carpenters Legis Emp Cmte, you should amend your Statement of Organization to



disclose the names of these committees and check the "Affiliated Committee" box on Line 6.

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
