If they represent 100% federal operating expenditures, please disclose these figures on Line 21(b) of the Detailed Summary Page.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
