Our previous Treasurer, Ken Vaughn, left our organization in November 2016. Since that time I have tried to update your system to specify me as the Treasurer.

First, I sent an updated "FEC FORM 1: STATEMENT OF ORGANIZATION" that month to your address. This update was never made by you to your system.

My 2nd attempt was to resubmit the form electronically by sending a scanned image in Adobe PDF format of the signed form by email to your Eliza Green, when asking for a password reset. I spoke with Eliza Green, who said that she was not able to do anything with the Form 1 that I sent her, that I needed to file it electronically.

I have tried to do this electronically. Please keep in mind that we are not a professional organization, and we are not professional lobbyists or anything like that. We are citizens that formed a local group, and had to forego the 501C route because of the Lois Lerner filth at the IRS.

Even so, we are trying to comply with your requirements.

Currently, I have two (2) problems.

- 1) I cannot correctly file any reports until Ken Vaughn is removed as Treasurer, and I am listed as the Treasurer.
- 2) Your current process for us requires that I use your software, "FEC File".


I tried to resolve the 1st problem by filing the correct form by mail, then by email. I am now trying to correct the problem using your web pages, but they don't work as you can see with the following screen captures.

After many different attempts, I am not able to resolve the 2nd problem, which means I am very late filing the last report that was due in July. I do not appear to have the last ".DCF" file, so I am missing the details of one of the reports that the prior Treasurer filed. Consequently, my current balance amount cannot be corrected.

To resolve the problem, I ask that we be able to file our reports online, without using your "FEC File". We will not be receiving any contributions totaling or exceeding \$50,000 this year. Since your online

system has all of the reports previously filed, I should not have the problem that I am having with my local copy of the "FEC File", which is missing an earlier report. Please let me know when this can be done, and if you need anything further from me.


