Please note that this is a conforming amendment to carry through corrections made to reports filed during the 2004 election cycle. The Committee disclosed payments for Salaries/Wages for this period on Schedule H4 for Line 21a, and Schedule B for Line 30b. The Committee pays its employees with 100% federal funds, and discloses the expenditures on Line 30b when the individual spends more than 25% of their compensated time in a given month on Federal election activity or activities in connection with Federal election. Those individuals who spend 25% or less of their compensated time in a given month on Federal election activity or activities in connection with a Federal election are paid with Federal funds, and allocated on Schedule H4. In either case, all amounts spent for employee-specific 'fringe benefits', consisting of health insurance, disability insurance, life insurance, retirement benefits and payroll taxes are paid for, and reported on a proportional basis equal to the amount associated with the individual that received the compensation and the funds with which the individual was paid.
