Dear Ms. Johnson:

In response to your inquiry dated December 5, 1997, referencing the October Monthly Report we have prepared the following responses:

**Your report(s) was not signed by the treasurer or designated agent listed on your Statement of Organization. Please amend your report(s) by providing the signature of an individual that is authorized to sign the report(s). 2 U.S.C. §434(a)(1) and 11 CFR §104.14(a) and (d). If a new treasurer has been appointed, please file an amended Statement of Organization (FORM 1) or a letter to reflect this change. By FEC Form 1 Dated December 9, 1993, (copy attached) which was filed with the FEC, DEAC listed Leonard Fichtner as Treasurer, Frank E. McCarthy as Assistant Treasurer and in addition, Thomas C. Goulionis, Director of Accounting, as a designated agent.**

Form 1, Line 8 states "...any designated agent (e.g., assistant treasurer)." Since "assistant treasurer" is listed as an example, DEAC felt that it had properly designated Mr. Goulionis as an agent to sign FEC reports.

However, if the FEC interprets "e.g." as limited to assistant treasurer please advise and we will immediately take steps to amend our Form 1, if necessary.

**Your report includes computer produced formats of Schedules A and B. Computer produced formats may only be used upon prior approval of the Commission. You should submit a separate sample format with a cover letter requesting approval. Until your format has been approved, FEC forms must be used. 11 CFR §104.2(d) In June of 1997 we created and had approved computer produced formats of Summary and Detail Summary Pages (see attachment). The computer generated formats of schedules A and B reside on our mainframe and have been in use since we began reporting in 1975. As with the Summary and Detail Summary Pages we created, I feel confident that the prescribed approval process at that time was followed.**

We are in the process of producing and installing a new system which will generate computer formats for all FEC forms. When operable, we will submit sample forms for approval by the FEC. In view of their use and acceptance by the FEC since 1975, we request permission to continue to use our mainframe generated Schedules A and B for the next few months.
