Note that Column B should reflect only the year-to-date totals for the calendar year 1998.

-The beginning cash balance of this report does not equal the ending balance of your Amended October Quarterly report, received 3/29/99. Please correct this discrepancy and amend any reports which may be affected by the correction.

-Your report was not signed. Please amend this report to include the original signature of the treasurer or the designated assistant treasurer. (2 U.S.C. §434(a))

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days
