Dear Ms. Jones:

The \$3,937.50 received from Alex Pearson, and reported on Schedule A supporting Line 15, represents a repayment of withholding taxes paid to the DC Government by the Committee on Mr. Pearson's behalf as no DC withholdings were deducted from his payroll. The Committee paid the taxes to the DC Government and Mr. Pearson now reimbursed the Committee.

With reference to Line 12, please note that the \$1,768.60 and \$3,350.00 transfers from Women Senate 2006 and New York Senate 2000 respectively were the final distributions upon termination of these joint fundraising committees. All gross contributions were previously disclosed on the Committee's regular monthly reports as memo entries.

With reference to Line 12, please note that New Mexico Senate 2006 transferred \$6,000.00 on 3/31/2006. The Commission must look at the December 2005 memo entries as well as the monthly memo entries totaling \$5,000.00 for January 1, 2006 through March 31, 2006. Washington Senate 2006 transferred \$38,000 on February 28, 2006 and \$25,000 on March 31, 2006. Again, the Commission must look at the November and December 2005 memo entries as well as the memo entries totaling \$49,100.00 for January 1, 2006 through March 31, 2006.


