This letter is in response to your letter of December 11, 2014 to me. I am enclosing a copy of the letter for our mutual convenience. I am replying both by fax and certified mail.

1. This part of your letter requested a review of Schedule A of the referenced report for incomplete information and requested that I correct the report and provide complete information. In my review the original report for line 11(c) appears that the information needed was the date of receipt for Item B on such page which was a purchase of a convention ad page for \$100 by AFSCME Council 61-People Account. The check for that ad was deposited on April 21, 2014 and such date has been added and made part of the amended report. This was the only portion of the report for that line that I found to be incomplete. I am enclosing an amended report reflection the addition of this date information for your review and filing with the FEC.
2. Part two of your letter deals with a contribution reflected on Schedule B to our District's Congressional Candidate and his committee ("PAT MURPHY FOR IOWA"). The contribution to the primary campaign was marked on our report for debt reduction. The committee report filed at the end of the month indicated that no debt existed. They reported this check received on June 7 and I was advised since receiving your letter that the committee had debt on that date which followed the June 3, 2014 primary which involved five candidates. I was also advised that receipts received after the primary but before the June 30 reporting period erased the committee debt at the end of the reporting period. I am enclosing a letter to that effect received (by e-mail) from Aaron Bly, the Campaign Manager for the committee. I am sending a copy of this correspondence to the committee and have been advised by them as indicated in the letter that they will furnish additional information if it is requested.
