This letter is in response to your inquiry dated May 8, 2009 in which you reference the 30 Day Post-General Report (10/16/08 – 11/24/08).

1. Schedule E – 24 H Notice Filing

With regard to the transaction referenced as “Designated Market Media,” the committee has researched its records and has determined that the communication was never publicly aired and, as such, the committee was not required to disclose the transaction on a 24 H Notice. The committee notes that it will amend its Post-General Report to move this transaction from Schedule E, Line 24 to Schedule B, Line 21b.

With regard to the remaining three referenced transactions, the committee has reviewed its records and the Commission’s website and has determined that all were reported as 24 H Notices as required. The committee notes that transactions on Schedule E were reported as of the date paid and once the expenditures qualified by date of dissemination as an independent expenditure, the required 24 or 48-hour Schedule E notice was then filed within the appropriate time frame. Therefore, no amendment is necessary with respect to these disbursements.

2. 24 H Notice – Schedule E Itemization

With respect to the two transactions referenced as “Jeff Merkley,” the committee did, in fact, disclose these on Schedule E, Line 24 of the Post-General Report. However, the candidate’s name on the 24 H Notices was incorrect as listed and should have been listed as Mark Udall which would have corresponded to Schedule E, Line 24. As such, the committee will amend its 24 H Notice for these two transactions to properly reflect the correct candidate’s name. All other information on the 24 H Notices filed was correct.


3. 24 H Notices & Schedule E – Differing Dates & Amounts

No portion of the expenditures for “Catering,” “Direct Mail Expense,” “Equipment Leasing,” “Printing,” “Media Consulting,” “Media Production,” or “Postage” was made on behalf of any specifically identified federal candidate. 
