Dear Mr. Davis:

I have enclosed for filing the following amended 1995 monthly reports for The National PAC, Inc., as requested in your three letters dated October 11, 1995. All the reports have been amended to show the "EVENT YEAR-TO-DATE" amount on the Schedule H4 supporting Line 21(a):

April Monthly (3/1/95 - 3/31/95) - Also amended to show the correct amount for Cash-on-hand on Line 8 column A; May Monthly (4/1/95 - 4/30/95); June Monthly (5/1/95 - 5/31/95); July Monthly (6/1/95 - 6/30/95); August Monthly (7/1/95 - 7/31/95); and the September Monthly (8/1/95 - 8/31/95) - this one was not requested by you but I included it so there would be no need for another letter.

As The National PAC has only had allocable administrative expenses so far this year I have followed your suggestion from our phone conversation and just kept a running total down each page and through to the next report. Please know that all future reports will be filed with this data included.

One of your letters also asked for a better explanation or description of the reimbursements from Mr. Richard H. Altman. Mr. Altman left the PAC in April of 1994. As part of his severance package he was allowed to stay on the PAC's payroll for a very small stipend in order to keep his insurance coverage for he and his family. The agreement was that the PAC would pay his premium on their group policy then he would reimburse the PAC for it. The description used therefore, does state the exact nature of these reimbursements. I hope this clarifies any misunderstanding of this situation.
