Dear Mr. Castle:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Column B, Line 7(c) of the Summary Page should equal the difference of Line 7(a) and Line 7(b).

-Line 11(e), Column B, of the Detailed Summary Page does not equal the sum of Lines 11(a) through 11(d). Please correct this discrepancy and file an amendment to your report. (11 CFR §104.3(a))

-The beginning cash balance of this report does not equal the ending balance of your Amended 12 Day Pre-General report, dated 4/1/99. Please correct this discrepancy and amend any reports which may be affected by the correction.

-Your calculations for the Cash Summary (Lines 23-27 of the Detailed Summary Page) appear to be incorrect. Our calculations disclose a discrepancy of \$36,982 ( $\$30,131 + \$456,200 = \$486,331 - \$435,715 = \$50,616$ ) Please provide the correct total for Line 27 of the Detailed Summary Page.

-Your report was not signed. Please amend this report to include the original signature of the treasurer or the designated assistant treasurer. (2 U.S.C. §434(a))

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
