This letter is prompted by the Commission's preliminary review of the report referenced above. - 1. Your report(s) was not signed by the treasurer or designated agent listed on your Statement of Organization (FEC Form 1). Please amend your report(s) by providing the signature of an individual that is authorized to sign the report(s). (2 U.S.C. §434(a)(1) and 11 CFR §104.14(a) and (d)) If a new treasurer has been appointed, please file an amended Statement of Organization or a letter (if not an electronic filer) to reflect this change.
- 2. Schedule B, supporting line 23 of the Detailed Summary Page, of you report discloses voided contributions with the purpose "Voided check #1070 dated 9/6/12". These transactions disclose a negative amount on Schedule B with the exception of the disbursement to "Lynch for Congress". Please provide additional clarifying information concerning this transaction and amend your report if necessary to properly disclose this disbursement. (11 CFR §104.8(d) (4))
- It has come to the attention of the Federal Election Commission that the reports you have filed during the current election cycle do not reflect the appropriate coverage dates for quarterly filing status. Please be advised of the filing dates and coverage periods for the 2011-2012 election cycle and fill in the appropriate dates on Line 5 of the Summary Page. For your information and consideration when preparing future filing, refer to the schedule provided for

your next filing. (U.S.C. 434(a) and 11 CFR §104.5(c))

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. Requests for extensions of time in which to respond will not be considered.

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
