1.Excessive Contributions reported on report and filed 10/28/14:

•Curbelo, Teresita – The campaign received 3 checks from her and her husband, Carlos Lino Curbelo totaling \$10,400 — \$7800 was accidentally attributed to Teresita Curbelo and \$2600 to Carlos Leno Curbelo. Copies of checks have been included – \$2,600 has been reclassified to her husband Carlos Lino Curbelo. Item has been corrected in latest amendment.

•Fanjul, Jose & Fanjul Jr., Jose- father and son with the same address, item does not need to corrected.

•Leyva, Giraldo, & Leyva, Giraldo - father and son with different addresses – item does not need to corrected.

•Ortiz, Hector P., \$2600 was from his son Hector Ortiz and \$900 was from Hector P. Ortiz, copies of checks included. Item has been corrected in latest amendment.

•Pelaez, Pedro- \$200 dollars has been attributed to his wife Cynthia Pelaez. Item has been corrected in latest amendment.

•Santos, Juan Carlos- Improper election designation. Item has been corrected in latest amendment.

•Publix Super Market- Improper election designation. Item has been corrected in amendment

8.In the process of converting our data from the state provided campaign reporting software to the Aristotle Campaign Manager software, the data was corrupted resulting in the improper reporting of contributions in our October quarterly report.
