## ATTACHMENT A

Please note the amount on Page 4, Line 28 is made up of two items—an \$80 refund to someone who paid for their tickets twice by mistake and \$600 that came from an unusual situation. The NCRP agreed to pay our dinner speaker \$2,000 and allow him to put out contribution envelopes for his organization. However, when he arrived he only had pamphlets describing his organization and no envelopes. Some attendees made checks out to his organization and others put cash in a basket. The speaker asked that we deposit the cash and give him a check for the \$600. Obviously, this \$600 was not income to our organization. I could not find an appropriate line item on which to report this transaction; therefore, I handled it like a refund and put it on Line 28. The amount is included on Page 3, Line 11(ii). Since I treated it like a refund, I showed it on Schedule B for backup for Line 28.

This was the only way I could figure out how to report this transaction and report our total deposits on Form 3X.




