This letter is to serve as a Form 99 – Miscellaneous Text in response to a letter received by the Montana Action Committee for Rural Electrification, ID C00139360.

On your letter dated March 30, 2007, you requested clarification for Schedule B information pertaining to reimbursements. Our original report showed the following:

Reimburse Hosted Bar	\$1,522.31
Reimburse for Auction Dinner	\$4,223.95

These expenses are for an annual fundraising dinner for the Action Committee. They are not tied in any way to specific candidates or issues. At the annual meeting of Montana Electric Cooperatives Association (the connected organization), an auction is held by Montana Action Committee for Rural Electrification.

Montana Electric Cooperatives Association pays the entire Hotel, Food, and Bar bill for the entire 4 day event. The portion of the bill that is related to Montana Action Committee for Rural Electrification is tracked separately by the convention center, and Montana Electric Cooperatives Association is reimbursed by Montana Action Committee for Rural Electrification.

There is no subsidizing by the connected organization, it is simply a reimbursement for expenses that belong to the Action Committee.
