

Dear Mr. Davis:

As we indicated by telephone during the week of November 15, 1993, a review of our records indicates that our contribution of \$1,500 to the Gephardt in Congress Committee was inadvertently issued without a notation attributing \$500 of the contribution to the 1994 general election cycle. The error was not apparent to the recipient committee, since they had no indication that the Miller & Chevalier PAC is not a multicandidate committee.

As indicated by the enclosed Amended Mid-Year Report and a copy of the attribution certification sent to the Gephardt in Congress Committee, we have taken the steps necessary to properly attribute the contribution. In addition, we have implemented a revision in our internal check issuance procedures to ensure that this mistake is not repeated in the future.
