This response addresses the issues raised in your Request For Additional Information (RFAI) dated August 18, 2016 to the Citizens United Super PAC LLC ("the Committee").

Items 1 and 2 in the RFAI seeks clarification about the adjustments to the total receipts, disbursements and debts disclosed on our reports. Unfortunately clerical errors made during the data import process resulted in the need to amend our report to disclose the corrected transactions and summary totals. Our amendment was filed shortly after the April Quarterly deadline in order to provide updated information as soon as possible.

Item 3 requests supporting documentation to the comment provided with our reports to briefly explain of our "best efforts" procedures. We are disclosing all information provided by our contributors, and missing information is requested within 30 days for all donors who contribute greater than \$200 in the calendar year. Please see the language below from our written follow-up to our original request for information:

Today we are also submitting an Amended April Quarterly Report to address Items 4, 5 and 6. As stated earlier, unintentional data entry errors made during the completion of the report also resulted in incorrect debt entries (and omissions). We are working with several vendors to improve the access to data and accuracy of our reports.

Additionally for Item 6, the Committee acknowledges that it failed to file 48 hour reports in connection with three separate direct mail communications. Two of the direct mail communications were mailed on or about February 22, 2016 and the third direct mail communication was mailed on or about March 9, 2016. The failure occurred because the direct mail firm that was responsible for the mailing failed to follow established protocol requiring that firm to advise the committee in advance of each mailing of date of the mailing and estimated costs of the mailing. Consequently, the committee did not learn that the three mailings had been publicly disseminated until it reviewed the financial data in connection with the preparation of its quarterly report. The direct mail firm has acknowledged to the committee that it erred in failing to follow the established protocol and has given the committee assurances that the error will not be repeated. The report itself identifies each of the independent expenditures for which a 48 hour report was not filed. The committee has also amended its report to correct clerical errors involving the dates of dissemination for certain items listed in the RFAI.

Finally, as stated in the response to Item 6, the report has been amended to correct clerical errors as to the dissemination date for certain items listed in the RFAI. In addition in response to Item 7, the Committee notes that the 48 hour reports filed in connection with the independent expenditures reported on Schedule E were based on good faith estimates of the costs associated with the communications. The Schedule E reports filed with the quarterly report reflect the actual costs of those communications. Thus, the total expenditures reflected in the 48 hour reports do not correspond precisely with the actual costs associated with the communications as reported on Schedule E and Line 24 of the quarterly report.
