The presidential general canvass expenditures aggregate to date totals per state are as follows: Colorado, \$60,185.01; New Hampshire, \$1,904.34; Nevada, \$24,101.70; Ohio, \$157,996.69; Pennsylvania, \$162,081.88; Wisconsin, \$53,908.51; Virginia, \$149,692.93.
