To the extent possible, we have updated the missing information identified in your letter, specifically the employers and occupation of individuals in excess of \$200 in contributions. The Committee continues the process of contacting the individuals you identified in order to obtain the additional requested information related to employer and occupation, and will amend its reports based on new information if obtained. The following is a listing of the Committees procedures to perform best efforts in trying to obtain the required information.(1) Required information is requested from donors in the solicitation materials on the response vehicle. Included on each response form is the statement. Although there is no limit on the amount you can contribute to the Hispanic Victory PAC, Federal Law requires us to use our best efforts to collect and report the name, mailing address, occupation, and employer of individuals whose contributions exceed \$200 in an election cycle. The response form then provides space for the donor to provide the requested information. (2) If the required information is not provided, a follow-up letter is sent to the donor within 30 days of the receipt of the contribution. The Committees primary method of contacting donors is through utilization of the email address provided by the donor, emailing a letter requesting the necessary additional information. If no email address has been provided, the donors are contacted by U.S. Mail. Finally, if no email address or mailing address is provided, donors are contacted to the extent possible through other identifying information that is available (phone, etc.). Each communication states: We are writing to you because we need some additional information from you in order to complete our FEC report on campaign financing, so we can be compliant per federal regulations. The letter will further request the specific information necessary. For example, You may have listed your occupation as self-employed. We simply need the type/field of work occupation and the name of your company, if applicable. The Committee updates its records as additional information is received. If the field subsequent FEC report contains the phrase Information Requested, then the Committee has not received any new information from the donor. The reports are amended with additional information when obtained.
