This amended filing responds to the Commission's RFAs of February 26 and March 24, 2010. Some transfers from the Democratic National Committee's State Partnership Program were incorrectly identified as proceeds from the WI Party Victory Fund joint fundraising program on the committee's June 2009 monthly through 2009 year-end reports. Records correction propagated errors in the reported year-to-date totals over this period. This amendment corrects those entries and makes consistent the reported year-to-date totals. Payroll-related items on Schedule H4 of this report were for employees that spent 25% or less of their compensated time on Federal activity. Any receipts on lines 15 or 17 were assessed at the usual and normal charge. Any fundraising expenses on line 21b were for the benefit of the committee and did not support a federal candidate. The receipts on Schedule A, supporting line 11, from unregistered committees Democratic Party of Dane County, Friends of Russ Decker, and Friends of Julie Lassa have been deemed permissible. These contributions were made by non-Federal candidates that had the required funds from Federally-permissible sources. The funds were verified to have come from permissible sources, and no amount exceeded the \$1,000 threshold that would require the committees to register with the Commission.
