Column B figures for the Summary and Detailed Summary Pages should equal the sum of the Column B figures on your previous report and the Column A figures on this report. Please file an amendment to your report to correct the Column B discrepancies for this report and all subsequent report(s) which may be affected by this correction. Note that Column B should reflect only the Calendar Year-to-Date totals. (2 U.S.C. § 434(b))
3. Your calculations for Line 32, Column A, appears to be incorrect. Please provide the correct totals on the Detailed Summary Page. (2 U.S.C. § 434)(b) (7))
