As this organization's contract controller, whose responsibilities include filing the election commission reports, I am submitting this letter to provide you and your organization with certain documentation and information in this matter.

The 1st quarter report was prepared using your electronic system, exactly as we have done for the many reports we have filed on behalf of our client over the past near 16 years. Enclosed is a copy of the report that we believed we e-filed successfully. It indicated that it passed validation. Accordingly, as we usually do, we printed the report and mailed it to the Ohio Election Commission via Certified Mail. Enclosed is a copy of the United States Postal Service's confirmation of timely delivery on 4/17/15.

These documents lead us to believe that the filing was accepted and submitted. We did not understand that the filing was 'valid' and then later rejected. We did NOT receive any email that indicated that rejection.

Based on the abovementioned facts and circumstances, and our consistent performance history and good faith effort to file the required information, I respectfully request that this Committee be held harmless in this matter.
