To Whom It May Concern:

We enclose our Notification of Multicandidate Status for filing. We inadvertently neglected to file this notification within 10 days after qualifying for multicandidate status on October 4, 2005.

I am submitting this letter after speaking by telephone with Jennifer Jaketic on April 12 and 13, 2006 about this delay. Ms. Jaketic investigated whether we should also amend the two periodic reports (for the periods ending December 31, 2005 and March 31, 2006), in which we did not "check the box" to indicate multicandidate status, and we now understand that we are not required to amend them because we have not made contributions exceeding \$2,100 to any single candidate or committee. We do appreciate Ms. Jaketic's assistance in this regard. Going forward, we will indicate our qualification as a multicandidate committee on all contribution checks. Per my discussion with Ms. Jaketic, we will also send a letter to each candidate and committee who received checks from us from October 4, 2005 through today, notifying them that we have qualified for this status.

Following my initial conversations with Ms. Jaketic, we submitted a form with the March 3, 2005 date for submission of our registration, but we understand from Ms. Jaketic's July 21, 2006 letter that we should use the April 4, 2005 date (the date the FEC confirmed our registration) instead of the March 3, 2005 date that we sent the form. The change from March 3, 2005 to April 4, 2005 also changes the date of qualification for multicandidate status: from September 3, 2005 to October 4, 2005.
